Those living in overcrowded accommodation, or are fleeing domestic violence, a council house is the answer to their prayers. In this current housing crisis the need for council housing outstrips the availability of homes. Not least because of the Right to Buy. There is also a huge shortfall of fully adapted accessible homes for the disabled, either new builds or retrofitted homes.
